- **16.** Liability to Damage: Contractor shall be fully responsible for safety & security to his workers. Contractor has to give written undertaking that he will be fully responsible for any accident/misshaping occurred during the work & he will indemnity IICC in case of any accident.
- **17. Evaluation & award of work:** The bids will be evaluated as per the Eligibility criteria given at Clause 14 & 15 above. The bids which are found to be fulfilling the eligibility criteria shall only be considered for opening of Price-Bids. IICC may seek clarifications in the bids from the bidders during the evaluation process. The work will be awarded to the lowest responsive (L-1), evaluated bidder and Work-order will be issued to the firm. IICC may like to visit the similar completed works of the successful bidder before considering their bid/award of work. Substantially responsive financial bids will be checked for any arithmetic errors, Arithmetic errors are to be rectified on the basis of the standard procedure as follows:
 - a) If there is a difference between the amount of rate in figure and in words of an item and the total amount is worked out, then the rate which corresponds to the amount worked by the bidder shall be taken as correct.

- **b)** If the bidder has not worked out the amount of an item or the same does not correspond with the rates written either in figures or in words, then the rate quoted by him in words shall be taken as correct.
- c) If the rate quoted by the bidder in figures and in words tallies but the amount is not worked out correctly, the rate quoted by the contractor shall be taken as correct and not the amount.
- **d)** If the selected bidder refuse to execute the work after award of work, his EMD will be forfeited.

18. Time of Completion and Extension for delay:

- i. The work shall be completed within 20 (Twenty) days from the date of receipt of work order from IICC.
- ii. Due to an event, not attributable to the contractor, causing delay, occurs or a variation order is issued, which makes it impossible to complete the work by scheduled completion date, IICC may consider extending the completion date on the specific request of the contractor.

19. <u>Dispute Resolution:</u>

- a) Any dispute and or difference arising out of or relating to this contract will be resolved through joint discussion of the authorities, representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole arbitrator appointed by the President IICC.
- b) The award of the sole arbitrator shall be final and binding on all the parties. The arbitration proceeding's shall be governed by Indian Arbitration and conciliation Act 1996 as amended from time to time.
- c) The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the contractor shall continue to be made in terms of the contract. Arbitration proceedings will be held at Delhi/New Delhi only.

Additional Conditions

- A. All the T&P is to be arranged by Contractor and nothing extra shall be paid on this account.
- B. The contractor shall make his own arrangements for making electric connections to equipment like drill machine etc. If any.
- C. The contractor shall be bound to follow the restrictions on the movement of labour, at IICC campus due to security or any other reason(s).No claim shall be entertained on this account.
- D. The contractor shall personally responsible for violation of any guidelines and shall have to pay the fine/penalty imposed by appropriate authority/Convener (Maintenance). No claim on this account shall be entertained.
